 - i. "The expected budget income/expenditure percentage is 58%. Actual income percentage to date is 62.5% and actual expenditure percentage is 54.8%. Tithe collections that were received by the 10th of the month contributed to a shortfall for the month in expenses. However, tithes received in the past week are in the range of the expected collections for a normal month. Despite the July shortfall,, the diocese continues to operate in the black for the year to date, and is expected to do so for the remainder of the calendar year." ~ David Francis, Diocesan Treasurer

- b. Proposal for three congregations to join forces in funding a Youth Ministry Intern, requesting a matching grant of their combined contributions (\$7,500), where no match request from an individual congregation exceeds the \$3,000 grant limit established by the Bishop.

Mr. Francis

- a. Question of what to do with excess/unspent income from previous year; sense evolved to put it into savings and have it accessible there as it always is by Council action/direction
- b. Line number 1 moved back to Tithe and the inserted "Beginning Balance" line is deleted from draft
- c. Fr. Snell expresses concern about moving additional HSA funds to pay more into Bishop; discussion ensued.
 - i. It was generally agreed that we should review all Diocesan policies.
 - ii. It was also generally agreed that via this year's budget "blessed excess," from 2017 we should make up the deficit in pension that Bishop Menees didn't receive in 2015, when he took a cut there to balance the budget.
 - iii. Bishop Menees left the room so that Council could discuss this issue of the funds from the deleted HSA line freely, to be called back when the matter is resolved.
- d. Motion: Estes That the Diocese pay the \$5,000.00 deficit to Bishop Menees' Pension from the 2015 budget, this year in 2018.
 - i. Second: Rogers
 - ii. Carried

- e. Motion: Fr. David Miller that the savings to the Diocese due to HSA being removed from budget \$4,500 be moved into Bishop Menees' salary as a salary increase for 2019.
 - i. Second: Prosser
 - ii. Discussion: Bishop had stated to David Francis that he did not want his salary to increase since we are in a declining situation overall; this motion could present bad optics. Others felt that six years was quite long enough without a raise for the Bishop, who works very hard for the Diocese
 - iii. 2 Nays, 7 Ayes; Motion Carried
