- 3. Bible Study Bp. Menees Colossians 1:9-20 What do we mean by Jesus Christ being Christ the King? We get the clearest picture of his Kingdom in Revelation 19. - e. St. John's Orinda update Bp. Menees Bp. Menees explained that St. John's Orinda has come into our diocese and the diocese will be handling their finances beginning on January 1, 2023 until they are able to manage it. The monthly transactions should be minimal. Cn. Dave Francis will coordinate a Zoom meeting with Good Shepherd Bookkeeping, St. John's, himself and Hephzibah Hovsepian to work the details out. They will start tithing 5% until they are voted into the Diocese officially at the 2023 Convention.

- f. All Saints Placerville- update
 They are holding their church pre-launch on December 4, 2022. They have
 funds being held by our diocese in a restricted fund until they are ready to
 hold the funds themselves. Fr. Richard James has been assigned to help
 them with their bylaws and incorporation, along with other items needed
 to become part of the diocese. In addition to All Saints Church, Fr. Ryan
 and Elizabeth Jones are developing a retreat center called Iona House.
- 8. Convention Debrief & Strategic Plan Implementation Bp. Menees Bp. Menees reviewed the next steps of the strategic plan. He also shared the follow up letter provided to clergy and asked for Standing Committee's feedback on both the letter and the strategic plan presentation by Pastor Jud Boies.
- 9. Request from the Rev. Andy Watson Bp. Menees A request was made from a bishop in another diocese to transfer the Rev. Andy Watson from the ADSJ to their diocese. The Rev. Watson was previously resident in the Anglican Diocese of San Joaquin. He moved away several years ago and left the diocese. He now requests to be received back into the ADSJ in order to transfer to the other diocese. The mind of the Standing Committee is to have the bishop of the new diocese receive the Rev. Watson rather than him returning here.
- David Peterson and Brandon LeTourneau, candidate and postulant to the presbyterate, respectively, will both graduate from Nashotah House in late Spring 2023. Bp. Menees and the COM are working with them to help move them through their process. They will be here in the diocese in Summer 2023. Dcn. Jack Franicevich may be called to help with a church plant in Pacifica. Bp. Menees and COM are helping to discern this. Juliet San Nicolas de Bradley was accepted as a postulant in October for the diaconate.
