The 2020 audit report was received by Linger, Peterson and Schrum. At the October Standing Committee meeting, Mr. Francis will present the audit report, along with suggestions from our auditors and how we are implementing these.

c. Proposal to change banks

The diocese office is no longer satisfied with using Wells Fargo due to customer service problems. These include inordinate amounts of time to complete necessary administrative transactions, long waits in line, and the lack of a business banker assigned to handle our account. The Diocese proposes to move our accounts to Central Valley Community Bank (CVBC), with the exception of the account(s) that must be kept at Wells Fargo due to the pending case with TEC.

CVBC indicated that based on an initial review of our accounts they would provide the same or similar services at the same cost or less than we currently pay.

Bp. Menees called for a Motion to open an account at Central Valley Community Bank for the Diocese of San Joaquin, doing business as the Anglican Diocese of San Joaquin, beginning as soon as practicable.

- 6. Insurance Requirements for Congregations Mr. Francis Mr. Francis has been working with Church Mutual and individual congregations who have no real property and minimal contents to adjust their policies to a lower cost. St. Martins, St. Mary the Virgin are examples of these churches. These will need to be addressed case by case until such time as existing lawsuits are resolved and we can move to an affinity program where churches can individually obtain their own insurance without the \$10,000 minimum required to be a part of the Diocese's policy.
- 7. Background Check and Training Policy- Subcommittee Rpt Ms. Pestana

A subcommittee was formed at the June meeting to review the MinistrySafe training policy. Subcommittee members are Dcn. Leslie, Mrs. Paul and Ms. Pestana. They reviewed the policy and submitted a list of recommendations. A proposal to update the *Rectors and Warden's Handbook* with these recommendations will be presented at the October Standing Committee meeting.

Bp. Menees is considering the establishment of a Compliance Officer position within the Diocese to handle compliance training and monitoring. Mr. Francis requested to be informed of any associated costs in advance of preparing the 2023 Diocesan Budget. A new position and changes to the policy would be on the agenda for the 2022 Convention.
