5. Financials

a. Financial Report - February 2023

Canon David Francis presented the financial report and answered multiple questions in detail. The monthly percentage is 16.6%. The actual income percentage is 18.5%. The actual expenditure percentage is 14.3%. There is a cash balance of \$19,833.08 income over expenditure at the end of two months.

Motion to approve Feb. Financial Report as presented: Mrs. Karlyn Paul 2nd: David chambers

Discussion followed:

i. Bishop Eric gave an account of his regular expenditures from the Bishop's Discretionary Fund. These expenditures included support for Fr. Richard and Martha Menees who are our missionaries to Uganda with \$150 monthly. He also oversees 5 congregations in Mexico and supports Fr. Jose Luis with \$200 monthly. Fr. Luis visits the congregations and uses this support for his expenses (bus transportation, hotel, etc.).

- ii. Mr. David Chambers brought up the idea of investing some of the Diocesan funds. After a discussion about possible option it was decided the Finance committee would meet, discussing investment plans and making a recommendation to the vestry.
- b. Written report for publication Motion to approve the first paragraph for publication: Mr. Paul Wanger 2nd: Fr. Luke Childs Motion carried
- c. The question of expenditures regarding GAFCON arose. The bishop reported that the airline tickets, hotel & conference fees have been paid.
 Bp. Menees, Cn. Conkle, Fr. Hall, Fr. Miller and Fr. Richard & Martha Menees are the official delegates of the ADSJ. The diocese is covering the airfare for Bp. Menees, Cn. Conkle and Fr. Hall. ADSJ is covering the hotel and conference fees for Fr. Richard and Martha. Fr. Miller's congregation is covering all of his expenses.
- d. The Bishop explained that a prayer for our Companion Diocese of Kigezi in Uganda is posted on our Diocesan website and encourages everyone to use the posted material for the Prayers of the People.
- 6. Draft Whistleblower Policy

The Diocese of San Joaquin has set the standard for the province; however, one thing we do not have is a whistleblower policy.

Bishop Eric presented a draft of this policy to the committee. The Whistleblower policy's purpose is to improve the protection of our children and the vulnerable adults. Bishop has appointed Deacon Leslie Arbegast as the Diocesan Ombudsman (an advocate who assists in fulfillment of our protection policies).

The Ombudsman will be a resource to all the churches across the Diocese, making sure the policies are fulfilled as well as being the point person to call in case of a canonical violation. Diocesan Chancellor has received and will review this policy. The policy, once approved, will be added to Diocesan online resources and to the Rector's and Warden's Manual.

The Standing Committee is asked to pray about the Whistleblower Policy and be prepared to discuss it and vote on it at the next meeting.

7. COM Report

Although the Bishop is the final determiner of the ordination of the candidates, Commission on Ministry assists him in finding ways to meet the needs of the Diocese in this every changing system world. More and more ordained clergy from other denominations can be
