### 6. Convention Prep

The Bishop reviewed all members of Commissions and Committees with the Standing Committee and brought to their attention that an error had been noticed with the service years in the previous Convention Position form. On some of the Commissions and Committees, the term of service is different for the Clergy and Laity, e.g. in the Ecclesiastical Court, Clergy serve 4 years while Laity serve for 3 years. In last year's convention minutes, the service year for both groups were noted to be 4 years. The dates on the Position form have now been corrected.

We are moving ahead with all the logistics for this year's Convention which is being held in Campus Bible in Fresno with Emmanuel Anglican Church being the host. Bishop Gaddie Akanjuna from our companion Diocese of Kigezi will be the keynote on Thursday and he will be teaching two sessions on Friday.

The Bishop is inviting not only the Clergy and delegates to participate but would like to see all come and enjoy a time of worship, a time of mission and ministry, a time of celebration.

This year's Convention is combined with the Mass of Chrism when the clergy will renew their vows. This has been a separate event in the past. The Bishop would also like to honor and bless the men and women at the Diocese who have chosen to dedicate their lives to Christ and have made vows of celibacy.

Next year's Convention will be held at St. Paul's in Visalia in their new facility which will be completed before the end of this year.

Only 6 churches have their own Ministry Safe account while it is expected that each church in the Diocese oversees its own Safety Compliance.
